(ii) This subsection shall not prohibit a business in which a legislator has an ownership interest from entering into a bona fide arm's length transaction with a recipient of economic development loan funds after those funds are disbursed;

(iii) The prohibition shall expire twelve (12) months after the legislator's term of office."
