"17-21-1104. Applicability of act to foreign and interstate commerce.

(n) A foreign registered limited liability partnership whose registration has lapsed for failure to pay fees or failure to maintain a registered agent in this state as provided in this article may apply to the secretary of state for reinstatement within two (2) years after the effective date of lapse as provided in W.S. 17-21-1107.

Section 3. Effective immediately, there is appropriated from the general fund to the secretary of state one-time funding of forty-seven thousand dollars (\$47,000.00) to implement the purposes of this act. Any unexpended, unobligated funds appropriated under this section shall revert on June 30, 2016 as provided by law.

Section 4.

(a) Section 3 of this act is effective immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.

(b) Except as provided in subsection (a) of this section, this act is effective January 1, 2016.". ZWONITZER, DN., CHAIRMAN
