24 this act. The chairman of the senate education committee and the
25 chairman of the house education committee shall continue to
26 serve as cochairmen of the select committee. Members of the
27 select committee shall be appointed as provided by 2011 Wyoming
28 Session Laws, Chapter 184, Section 4(b) to serve on the select
29 committee through December 31, 2018. Select committee members
30 shall receive compensation, per diem and travel expense
31 reimbursement in the manner and amount prescribed under W.S.
32 28-5-101. Payment shall be from amounts appropriated under
33 section 6(b) of this act. The appointing authority for any
34 member who vacates membership shall fill the vacancy.".
