36 and mileage, but no salary for preparation as provided in W.S.
37 28-5-101(e)(iii), for their official duties as members of the

42 (a) There is appropriated from the general fund for the
43 purposes of this act:
44
45 (i) Twenty-five thousand dollars (\$25,000.00) to the
46 legislative service office for providing the payments to task

1 force members who are legislators as authorized in section 1 of
2 this act;

4 (ii) Fifteen thousand dollars (\$15,000.00) to the
5 governor's office for providing the payments to task force
6 members who are not state employees or legislators as authorized
7 in section 1 of this act.

9 (b) Funds appropriated in subsection (a) of this section
10 shall be for the period beginning with the effective date of
11 this act. Notwithstanding any other provision of law, these
12 appropriations shall not be transferred or expended for any
13 other purpose and any unexpended, unobligated funds remaining
14 from these appropriations shall revert as provided by law on
