Motorboat registration and certificate fee.

A BILL

for

1 AN ACT relating to game and fish and motorboats; increasing
2 certain watercraft fees administered by the game and fish
3 department; and providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** W.S. 41-13-104(f), (k) and (m) and
8 41-13-109(a)(i) and (ii) are amended to read:

10 **41-13-104. Application for certificate; issuance of**
11 **certificate and assignment of number; conformity with**
12 **federal numbering system; expiration and renewal of**
13 **certificate; transfer of ownership; duplicate certificate;**
14 **manufacturer and dealer certificates.**

1 (f) Each certificate of number issued under this act
2 expires on December 31 of the last year of valid
3 registration under the certificate unless sooner terminated
4 or discontinued under this act. A duplicate number may be
5 obtained by an owner upon application to the department,
6 which may require payment of a fee of not more than ~~five~~
7 ~~dollars (\$5.00)~~ ten dollars (\$10.00) as adjusted pursuant
8 to W.S. 23-1-302(a) (xxxii). Certificates of number may be
9 renewed by the owner in the same manner provided under this
10 act for obtaining initial certification.

11

12 (k) If any certificate of number is lost, mutilated
13 or becomes illegible, the owner of the motorboat for which
14 the certificate was issued may obtain a duplicate
15 certificate upon application to the department. The
16 department may set and collect payment of a fee for a
17 duplicate certificate not to exceed ~~five dollars (\$5.00)~~
18 ten dollars (\$10.00) as adjusted pursuant to W.S.
19 23-1-302(a) (xxxii).

21 (m) A person engaged in the manufacture or sale of
22 motorboats may, upon application to the department in the
23 manner and on forms prescribed by rule and regulation,

1 obtain certificates of number for use in the testing or
2 demonstrating of these motorboats. The fee for each
3 registration under this subsection shall be ~~fifteen dollars~~
4 ~~(\$15.00)~~ thirty dollars (\$30.00) as adjusted pursuant to
5 W.S. 23-1-302(a)(xxxii). The numbers assigned by
6 certificates of number issued under this subsection shall
7 be temporarily placed on the watercraft to be tested or
8 demonstrated.

10 **41-13-109. Motorboat registration fee.**

12 (a) The nonrefundable and nontransferable
13 registration fee for motorboats is:

14
15 (i) ~~Fifteen dollars (\$15.00)~~ Thirty dollars
16 (\$30.00) as adjusted pursuant to W.S. 23-1-302(a)(xxxii)
17 for one (1) year; or

18
19 (ii) ~~Forty dollars (\$40.00)~~ Eighty dollars
20 (\$80.00) as adjusted pursuant to W.S. 23-1-302(a)(xxxii)
21 for three (3) years.
