28 under W.S. 9-1-417 the state treasurer and the state
29 auditor may utilize up to one hundred fifty million
30 dollars (\$150,000,000.00) in interfund loans from the
31 unexpended, unobligated balance of the legislative
32 stabilization reserve account for deposit to the
33 strategic investments and projects account as
34 necessary to meet appropriations from that account and
35 contract obligations of the ~~department of~~
36 ~~administration and information~~ state construction
37 department and University of Wyoming incurred for
38 purposes of this act. The state treasurer and the
39 state auditor shall not utilize interfund loans under
40 this section to meet appropriations for Mineral
41 impacted roads in section 7, priority VI and section
42 8, priority V, appropriations for the Ludden library
43 in section 7, priority II, ~~or~~ or appropriations for the
44 Capitol bldg. rehabilitation and restoration account
