A BILL

for

1 AN ACT relating to government ethics; requiring elected
2 officials and members of the legislature to disclose
3 information on contracts with the state as specified; and
4 providing for an effective date.

6 *Be It Enacted by the Legislature of the State of Wyoming:*

8 **Section 1.** W.S. 9-13-108(a)(intro), by creating a new
9 paragraph (iii) and (c) is amended to read:

11 **9-13-108. Disclosure required.**

1 (a) Not later than January 31 annually, each of the
2 state's five (5) elected officials and each member of the
3 Wyoming legislature shall file a financial disclosure form
4 with the secretary of state. The form shall be signed by the
5 elected official or legislator filing it and under a
6 certification that it is accurate. Except as otherwise
7 provided in this subsection, the financial disclosure form
8 shall contain the following information current as of January
9 15 of that year:

11 (iii) A list of all state entities the person, or
12 the person's business enterprise in which the person owns ten
13 percent (10%) or more interest, has a contract with for
14 services and supplies in an amount greater than five thousand
15 dollars (\$5,000.00) for which the term is more than one
16 hundred eighty (180) days. The list shall include all
17 contracts subject to this paragraph entered into by the
18 elected official or legislator on and after January 15 of the
19 prior year. For each contract, this list shall include the
20 name and address of the business enterprise, if applicable,
21 and state entity, the type and description of the contract
22 and the effective date and term of the contract. For purposes
23 of this paragraph "state entity" as defined in W.S.

1 9-13-102(a)(xv) shall include a court or an agency in the
2 judicial branch.

4 (c) The disclosure form shall be as prescribed by the
5 secretary of state but in substantially the following form:
