## A BILL

for

1 AN ACT relating to education; establishing the Wyoming works program at community colleges; providing for grants for 2 students and funding for community college technical programs 3 approved to meet labor and economic development needs; 4 specifying requirements for student grants and for community 5 6 college program funding; providing for administration; 7 requiring reports; reappropriating funds; providing specifying funding distributions; 8 appropriation; 9 providing for an effective date.

3	21-18-401. Wyoming works program created; short title.
4	
5	This article may be cited as the "Wyoming works program".
6	
7	21-18-402. Definitions.
8	
9	(a) As used in this article:
10	
11	(i) "Academic term" means the fall semester or
12	term, the spring semester or term, summer school, or other
13	defined period of time within a term or semester in which the
14	approved credential program or course is offered. In this
15	article, "term" and "semester" have the same meaning. If an
16	approved credential program or course encompasses a defined
17	period of less than a full semester or term the beginning of
18	the defined period shall be considered the beginning of the
19	term or semester for that program or course;
20	
21	(ii) "College" or "community college" means an
22	institution established under the Wyoming Community College
23	System Code;

1 2 (iii) "Commission" means the Wyoming community 3 college commission; 4 5 (iv) "Consortium" means two (2) or more colleges sharing or jointly delivering credential programs in more 6 than one (1) geographic location, by sharing resources or 7 otherwise collaborating in order to more efficiently provide 8 9 access to credential programs for students; 10 11 (v) "Cost of attendance" means the sum cost of 12 tuition, mandatory fees, room and board, books and supplies, 13 travel and personal expenses to attend a community college as determined annually by the college in accordance with W.S. 14 15 21-18-404(b); 16 17 (vi) "Credential" means a license, certificate or other government or industry recognized 18 19 qualification for working in a trade or occupation in this 20 state, including, but not limited to, drivers of commercial 21 motor vehicles, welders, machine shop operators or other workforce training programs. College academic credit and an 22 applied science degree or certificate may be earned in a 23

- 1 credential program, but college academic credit shall not be
- 2 a requirement for a credential program;

- 4 (vii) "Unmet financial need" means the cost of
- 5 attendance minus the sum of expected family contribution and
- 6 all federal, state, local, institutional and privately funded
- 7 scholarships or grants received by the student, all as
- 8 determined by the community college. The college shall use
- 9 the most recent federal free application for federal student
- 10 aid form to determine expected family contribution and shall
- 11 do so annually in accordance with W.S. 21-18-404.

- 21-18-403. Wyoming works program created; eligibility
- 14 requirements.

15

- 16 (a) There is created the Wyoming works program for
- 17 Wyoming community college students.

- 19 (b) Under the Wyoming works program, subject to the
- 20 availability of funds as determined by the legislature, the
- 21 state may provide grant funds pursuant to this article on
- 22 behalf of an eligible student who has been accepted by and
- 23 enrolled in a community college to pursue a credential program

or

1	approved by the commission for the Wyoming works program, who
2	has demonstrated Wyoming residency as determined by the
3	community college at which the student is enrolled and who is
4	not ineligible under subsection (c) of this section. No
5	college shall require a high school diploma or high school
6	equivalency certificate as a prerequisite for admission to a
7	credential program funded in whole or in part with monies
8	under this article, unless the credential program is included
9	within a college academic credit program requiring the
10	diploma or equivalency certificate and the college provides

equivalency certificate.

14 (c) No student shall be eligible for a grant under this
15 article for more than six (6) academic terms. A student is
16 not eligible for a grant under this article if he:

18 (i) Is not a United States citizen or a permanent
19 resident alien who meets the definition of an eligible
20 noncitizen under federal Title IV requirements or
21 requirements of a subsequent similar federal enactment;

1 (ii) Has not complied with United States selective 2 service system requirements for registration, if the 3 requirements are applicable to the student; 4 5 (iii) Is in default on a federal Title ΙV education loan. Nothing in this paragraph prohibits a student 6 who is otherwise eligible for a grant under this article and 7 8 has fully repaid a defaulted loan or is no longer in default, 9 from receiving a grant for future academic terms; 10 11 (iv) Owes a refund under a federal Title IV 12 student financial aid program or a subsequently enacted 13 similar federal student financial aid program, or a student 14 financial aid program administered through the state. Nothing in this paragraph prohibits a student who is otherwise 15 eligible for a grant under this article and has fully paid 16 17 the refund owed, from receiving a grant for future academic 18 terms; 19 20 (v) For continued enrollment in a credential 21 program if he fails to make satisfactory academic progress as required for the credential program by commission rule. 22

1 21-18-404. Student grants; amounts.

2

3 There shall be made available student grants under the Wyoming

4 works program. No grant shall exceed two thousand two hundred

5 fifty dollars (\$2,250.00) for attendance in a credential

6 program in any one (1) school year. One-half (1/2) of the

7 annual award shall be provided to the student at each fall

8 and spring academic term of qualification, unless the

9 credential program or course is for a defined period of less

10 than a full semester or the student elects to reserve any

11 portion of the annual award for attendance at a subsequent

12 summer school term. For credential programs of one (1) term

13 or less, cost of attendance and unmet financial need shall be

14 calculated on a projected annual basis, but the annual award

15 amount shall be provided in full in the term of attendance,

16 on a prorated basis.

17

18 21-18-405. Administration; rules and regulations.

19

20 (a) Distribution of funds for student grants shall be

21 administered by the commission in accordance with the

22 following:

1 (i) Distributions shall be made from funds 2 available in the Wyoming works program account; 3 4 (ii) Student grants shall be limited to students 5 enrolled in an approved credential program; 6 7 (iii) Colleges shall apply to the commission for grant funds to be expended by the college on eligible students 8 9 for approved credential programs. The commission shall 10 provide student grant funding to each college based upon the 11 actual or projected enrollment in the approved program and 12 the commission's prioritization of program funding accordance with this article and rule of the commission; 13 14 15 (iv) Students shall make application for grants 16 under this article with the community college at the time of applying for admission or in any event prior to the beginning 17 of the applicable credential program at the college. 18 The 19 application shall contain information required by rule of the 20 commission; 21 (v) For students transferring from a community 22 23 college to another community college and making application

- 1 for continuance of a grant, the college from which the student
- 2 is transferring shall at the student's request provide a list
- 3 of all academic terms of attendance in which a Wyoming works
- 4 grant was received by the student;

- 6 (vi) Each community college receiving an
- 7 application from a student applying for a Wyoming works grant
- 8 shall determine the student's eligibility for the grant. Each
- 9 community college shall certify to the commission not later
- 10 than thirty (30) days after the academic term or program
- 11 commences, a list of students enrolled at the college who
- 12 qualify for a grant under this article, including the maximum
- 13 amount of each grant. The executive director of the community
- 14 college commission shall verify within ten (10) days after
- 15 receiving a list from a community college whether there is
- 16 any duplication of students on the community college list
- 17 with previously submitted student grant lists and shall
- 18 certify to the commission the maximum amount a college would
- 19 be eligible to receive for student grants under this article
- 20 for an approved program;

- (vii) For students attending more than one (1)
- 23 community college the commission may distribute any student

- 1 grant funds provided on a proportionate basis as determined
- 2 by rule of the commission;

- 4 (viii) Following each spring semester, each
- 5 college shall refund to the commission the difference, if
- 6 any, between the amounts distributed to colleges for student
- 7 grants under this section for the spring term and the previous
- 8 fall and summer terms and the amount actually expended by
- 9 colleges on those student grants. Colleges shall refund the
- 10 difference not later than August 1. The commission shall
- 11 deposit all payments under this paragraph to the Wyoming works
- 12 program account.

13

- 14 (b) The commission, in consultation with each community
- 15 college, shall by rule designate a date or dates for each
- 16 academic year upon which each college shall make the final
- 17 computation for unmet need for students eligible to receive
- 18 a grant under this section, consistent with each college's
- 19 schedule for determining actual cost of attendance for
- 20 students at that college.

- 22 (c) The commission shall, in consultation with
- 23 community college admissions officers and financial aid

5	(i) A means for informing potential students of

16	(d) The commission may conduct an audit of any college
17	participating in the student grant program under this article
18	to determine compliance with any student grant provision of
19	this article.

21	21-18-406. Student grant limitations.
22	

1	To the extent a student grant under this article would, when
2	combined with any grant or scholarship from a student
3	financial aid program administered through the state or any
4	state institution, in any academic term exceed the cost of
5	attendance at the community college, the grant under this
6	article shall be reduced by the amount necessary to not exceed
7	the cost of attendance. The commission shall by rule require
8	that student grant funds under this article shall be provided
9	for unmet financial need and only after all other public or
10	private grants, scholarship or other financial aid available

21-18-407. College program grant funds; distribution by community college commission.

for the student's enrollment in the credential program have

(a) From monies within the Wyoming works program account the commission shall distribute to colleges funds for instructor positions, recruitment and marketing materials and to acquire instructional and resource materials, classroom equipment and other resources necessary to support the Wyoming works program. The community colleges may collaborate on the use of funds received from the Wyoming works program

- 1 account, including entering into consortium agreements for
- 2 operation of credential programs.

- 4 (b) Funds distributed under this section shall be
- 5 subject to the following:

- 7 (i) The funds shall be designated as Wyoming works
- 8 program funding, accounted for separately from funding
- 9 provided under the allocation model under W.S. 21-18-205(c)
- 10 and special purpose funding under W.S. 21-18-205(e) and shall
- 11 not be transferred to or expended for any other purpose;

- 13 (ii) The funds shall be expended only for
- 14 credential programs approved by the commission. The
- 15 commission shall develop by rule criteria under which to
- 16 approve credential programs and to determine the amount of
- 17 funding provided. The process for approving programs for
- 18 funding shall reflect the primary goals of the Wyoming works
- 19 program to develop technical skills most in demand in a
- 20 college's service area or colleges' combined service areas
- 21 and to fund programs which are most able to immediately
- 22 respond to that demand by making grant funds available to
- 23 students able to acquire the credential needed. The criteria

1	for funding amounts shall include, at a minimum, the need for
2	the program in the community, the region's workforce needs
3	and the contribution of the program to the state's overall
4	economic development. Priority shall be given to programs
5	developed and delivered through consortiums and partnerships
6	of colleges, to those programs which, based upon enrollment
7	and projected enrollment, are most able to respond to industry
8	training needs in the community and region and to programs
9	with private funds made available to support the program.
10	Colleges shall make application for funding of credential
11	programs to the commission at times determined by rule of the
12	commission;
13	
14	(iii) Any amount of funding distributed under this
15	section which remains unexpended or unencumbered at the end

19 **21-18-408.** Account created.

20

The Wyoming works program account is created. The account shall consist of funds appropriated by the legislature, gifts and grants accepted by the state and such other funds as

of the biennial budget period for which it was distributed

shall revert to the Wyoming works program account.

- 1 directed by law. Monies within the account are continuously
- 2 appropriated to the commission for distribution to colleges
- 3 as provided in this article. Interest and other earnings on
- 4 funds within the account shall be credited to the account.
- 5 Unexpended and unencumbered monies within the account at the
- 6 end of each fiscal year shall not lapse but shall remain in
- 7 the account.

- 9 21-18-409. Legislative oversight and authority;
- 10 reporting.

11

- 12 (a) Nothing in this article shall be construed to
- 13 constitute an entitlement to a grant established and funded
- 14 by the legislature. Wyoming works grants shall be subject to
- 15 legislative appropriation and the legislature reserves the
- 16 right to modify or terminate the program established under
- 17 this article at any time.

- 19 (b) The Wyoming community college commission shall
- 20 report to the legislature by October 1 of each year the
- 21 colleges, programs, industries and total number of students
- 22 served by the Wyoming works program in the preceding school
- 23 year. The report shall specify the funding provided to each

15 **21-18-205.** Appropriation and distribution of state 16 funds; restrictions; budget authority.

- 18 (h) The commission may request funding for and shall
- 19 distribute funds to colleges as provided in the Wyoming works
- 20 program. Funds requested for the Wyoming works program shall
- 21 be requested by an exception budget and designated as separate
- 22 special funding for the Wyoming works program only. Funds
- 23 <u>distributed pursuant to the Wyoming works program shall be</u>

1 accounted for and distributed separately from the funding

2 <u>allocation model under subsection (c) of this section and</u>

3 <u>from special funding distributed pursuant to subsection (e)</u>

4 of this section.

The unobligated, unencumbered balance in the 6 Section 3. 7 Wyoming workforce development-priority economic 8 partnership subaccount created by W.S. 9-12-1404(a)(iii) 9 shall be deposited to the Wyoming works program account. 10 addition, from funds within the strategic investments and 11 projects account there is appropriated to the Wyoming works 12 program account funds as necessary so that the total 13 appropriation to the Wyoming works program account under this section is equal to ten million dollars (\$10,000,000.00). 14 15 These appropriations shall be made upon the effective date of 16 this act. All funds deposited to the Wyoming works program 17 account under this section shall only be expended as provided by the Wyoming works program and this act. Notwithstanding 18 19 any other provision of law, these appropriations shall not be 20 transferred or expended for any other purpose.

Section 4. This act is effective immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.
