1 AN ACT relating to public school finance; modifying the  
2 education resource block grant model to provide additional  
3 funding to certain school districts for teacher positions;  
4 modifying a definition; providing an appropriation; and  
5 providing for an effective date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

9 **Section 1.** W.S. 21-13-101(a)(xvii) is amended to read:

11 **21-13-101. Definitions.**

13 (a) As used in this chapter:

1 (xvii) "Attachment A" to 2011 House Bill 0127,  
2 2011 Wyoming Session Laws, Chapter 185, as amended by 2012  
3 Wyoming Session Laws, Chapter 99, 2017 Wyoming Session Laws,  
4 Chapter 205, 2018 Wyoming Session Laws, Chapter 137 and 2019  
5 House Bill HB0136, consists of an enumeration of model  
6 components as enacted into law, summarizing and executing  
7 recommendations contained within the 2010 cost of education  
8 study, as modified by the legislature, and is hereby  
9 incorporated into this chapter by this reference;

11 **Section 2.** 2011 Wyoming Session Laws, Chapter 185,  
12 ATTACHMENT "A" (b) by creating a new paragraph (xli) is  
13 amended to read:

17 ATTACHMENT "A" CONTAINS AN ENUMERATION OF EDUCATION  
18 RESOURCE BLOCK GRANT MODEL COMPONENTS SUMMARIZING  
19 AND EXECUTING RECOMMENDATIONS CONTAINED IN THE 2010  
20 COST OF EDUCATION STUDY AS FOLLOWS:

22 (b) Notwithstanding components specified in  
23 the 2010 cost of education study accepted by the

1 legislature, the Wyoming education resource block  
2 grant model components and the resourcing for those  
3 components, as enacted by the legislature, shall be  
4 as follows:

5  
6 (xli) Teacher adjustment: District ADM  
7 less than or equal to  
8 750, resource with  
9 2.0 FTE teacher  
10 positions in addition  
11 to all other teacher  
12 resources; district  
13 ADM greater than 750  
14 and less than or equal  
15 to 1500, resource  
16 with 1.0 FTE teacher  
17 position in addition  
18 to all other teacher  
19 resources.

20  
21 **Section 3.** Four million dollars (\$4,000,000.00) is  
22 appropriated to the department of education from the school  
23 foundation program account for the purpose of making

1 foundation program payments to school districts in accordance  
2 with law for the period beginning July 1, 2019 and ending  
3 June 30, 2020. Notwithstanding any other provision of law,  
4 this appropriation shall not be transferred or expended for  
5 any other purpose and any unexpended, unobligated funds  
6 remaining from this appropriation shall revert to the school  
7 foundation program account on June 30, 2020.

9 **Section 4.** This act is effective July 1, 2019.
