(a) To promote the public health, safety, morals and 2 3 general welfare of the county, each board of county 4 commissioners may regulate and restrict the location and use 5 of buildings and structures and the use, condition of use or occupancy of lands for residence, recreation, agriculture, 6 industry, commerce, public use and other purposes in the 7 unincorporated area of the county. However, nothing in W.S. 8 9 18-5-201 through 18-5-208 shall be construed to contravene 10 any zoning authority of any incorporated city or town and no 11 zoning resolution or plan shall prevent any use or occupancy 12 reasonably necessary to the extraction or production of the 13 mineral resources in or under any lands subject thereto. No regulation, ordinance, resolution, condition of development, 14 comprehensive plan or subdivision plan shall include or 15 16 require:
