5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** W.S. 22-5-204(b) and 22-5-301(a) are amended
8 to read:

10 **22-5-204. Application for nomination or election; party**
11 **registration; form.**

13 (b) An eligible person seeking nomination or election
14 for a partisan office shall:

1 (i) Meet all applicable qualifications to be
 2 elected to office which are set forth in the United States
 3 and Wyoming constitutions;

 5 (ii) Be registered in the party whose nomination
 6 he seeks; and ~~shall~~
