## A BILL

for

1 AN ACT relating to the livestock board; creating a livestock

2 enforcement account to reimburse county sheriffs for eligible

3 expenses and to conduct training as specified; requiring

4 promulgation of rules; providing an appropriation; and

5 providing for effective dates.

7 Be It Enacted by the Legislature of the State of Wyoming:

9 **Section 1.** W.S. 11-18-120 is created to read:

10

11 11-18-120. Livestock enforcement account;

12 reimbursement of county sheriffs by livestock board; rules.

14 (a) There is created the livestock enforcement account.

15 Unexpended, unobligated funds in the account shall revert to

- 1 the general fund at the end of a biennium. Unless otherwise
- 2 provided by law, the balance in the account shall not exceed
- 3 five hundred thousand dollars (\$500,000.00).

- 5 (b) Funds in the livestock enforcement account shall
- 6 only be expended by the livestock board to:

7

- 8 (i) Reimburse county sheriffs for activities
- 9 relating to the enforcement of livestock laws, including
- 10 patrol and personnel expenses and in-state and out-of-state
- 11 livestock investigations;

12

- 13 (ii) Provide training to county sheriffs regarding
- 14 livestock enforcement.

15

- 16 (c) Notwithstanding any other provision of law,
- 17 reimbursement provided under paragraph (b)(i) of this section
- 18 shall be credited to the applicable account, fund, subaccount
- 19 or other accounting unit within the budget of a county which
- 20 is controlled by the county sheriff. Reimbursement provided
- 21 under paragraph (b)(i) of this section shall not be withheld
- 22 by a board of county commissioners from a county sheriff or

23 deducted from the budget of a county sheriff.

- 2 (d) The livestock board shall adopt rules to implement
- 3 this section, which shall include eligible expenses, rates
- 4 and procedures for reimbursement.

- 6 **Section 2.** W.S. 11-18-103(a) by creating a new
- 7 paragraph (x) is amended to read:

9 11-18-103. Livestock board; powers generally.

10

- 11 (a) In addition to powers and duties hereinafter
- 12 provided, the Wyoming livestock board shall:

- 14 (x) Administer the livestock enforcement account
- 15 created by W.S. 11-18-120.

- 17 **Section 3.** There is appropriated two hundred fifty
- 18 thousand dollars (\$250,000.00) from the general fund to the
- 19 livestock enforcement account created by W.S. 11-18-120. The
- 20 livestock board may include a request for an appropriation to
- 21 the livestock enforcement account in its 2021-2022 standard

22 budget request.

1 Section 4. The livestock board shall promulgate rules 2 as required by this act. 3 4 Section 5. 5 (a) Section 4 of this act is effective immediately upon 6 completion of all acts necessary for a bill to become a law 7 as provided by article 4, section 8 of the Wyoming 8 9 Constitution. 10 (b) Except as otherwise provided by subsection (a) of 11 this section, this act is effective July 1, 2019. 12
