A BILL

for

1 AN ACT relating to food and drugs; prohibiting
2 misrepresenting a product as meat that is not derived from
3 harvested production livestock or poultry; requiring
4 rulemaking; and providing for an effective date.

6 *Be It Enacted by the Legislature of the State of Wyoming:*

8 **Section 1.** W.S. 35-7-111(a) by creating a new paragraph
9 (xiii) and 35-7-119(e) are amended to read:

11 **35-7-111. Prohibited acts.**

12

13 (a) No person shall:

14

1 (xiii) Represent a product as meat in labeling,
2 advertising or other sales promotion unless the product is
3 derived from harvested livestock, poultry or exotic livestock
4 as those terms are defined in W.S. 11-26-101(a),
5 11-32-101(a)(iv) and 23-1-102(a)(xvi).

6
7 **35-7-119. Fair packaging and labeling provisions.**

8
9 (e) The department shall promulgate rules with respect
10 to labeling. Every retailer and every wholesaler who sells or
11 offers for sale in this state through an establishment or
12 otherwise any:

13
14 (i) Meat, which that is the product of any country
15 foreign to the United States, shall clearly label the meat as
16 "imported," naming the country of its origin*i*. ~~The department~~
17 ~~shall promulgate rules and regulations with respect to~~
18 ~~labeling. As used in this subsection:~~

20 (ii) Meatlike product that is not derived from
21 harvested livestock, poultry or exotic livestock as those
22 terms are defined in W.S. 11-26-101(a), 11-32-101(a)(iv) and

1 23-1-102(a)(xvi), shall clearly label the product as an
2 "imitation food";

4 (iii) As used in this subsection:

5

6 ~~(i)~~(A) "Meat" means the edible part of the muscle
7 of animals, which is skeletal or which is found in the tongue,
8 in the diaphragm, in the heart or in the esophagus, with or
9 without the accompanying or overlying fat, and the portions
10 of bone, skin, sinew, nerve and blood vessels which normally
11 accompany the muscle tissue and which are not separated from
12 it in the process of dressing, but shall not include the
13 muscle found in the lips, snout or ears, nor any edible part
14 of the muscle which has been manufactured, cured, smoked,
15 cooked or processed;

16

17 ~~(i)~~(B) "Retailer" means a person regularly
18 engaged in the business of selling meat at retail to the
19 public, and selling only to the user or consumer and not for
20 resale;

21

1 ~~(iii)~~(C) "Wholesaler" means a person
2 regularly engaged in the business of selling meat at wholesale
3 to retailers for subsequent sale at retail to the public.

5 **Section 2.** This act is effective July 1, 2019.
