21 official website for publication of information required to be  
22 published under this section. If a newspaper is not published in  
23 the city or town and the city or town's official website is not  
24 designated for publication the proceedings or ordinances shall be  
25 posted for at least ten (10) days in the city or town clerk's  
26 office and in such other places as the governing body determines.  
27 The clerk of each city or town shall within twelve (12) days after  
28 adjournment of every meeting, furnish the newspaper a copy of the  
29 proceedings of the meeting. Except for salaries and wages published  
30 under subsection (b) of this section, the copy shall include any  
31 bill presented to the governing body stating the amount of the  
32 bill, the amount allowed, the purpose of the bill and the claimant.  
33 Claims for part-time employees may be summarized by department  
34 without listing each part-time employee. The newspaper shall  
35 publish the copy of proceedings within nine (9) days after  
36 receipt."
