1 (a) The acquisition of meat from animals by an 2 informed end consumer shall not constitute the sale of meat 3 products in contravention of this act and shall not be 4 prohibited if all of the following conditions are met: 5 The meat is delivered pursuant to an animal б (i) 7 share and is: 8 9 (A) Received from the farm or ranch where 10 an animal or herd subject to the animal share is located; 11 12 (B) Received by or on behalf of an owner of 13 an animal share; 14 (C) Obtained from the particular animal or 15 16 herd subject to the animal share. 17 18 (ii) Ownership of each animal is established 19 prior to slaughter; 20 21 (iii) A prominent warning statement that the meat has not been inspected is delivered to the informed 22
