A BILL

for

1 AN ACT relating to public funds; repealing the strategic 2 investments and projects account; repealing subaccounts within the strategic investments and projects account; 3 4 repealing the legislative deficit control account that is funded from the strategic investments and projects account; 5 revising account distributions as specified; providing for 6 7 the transfer from and reversion of funds to the repealed 8 accounts; and providing for an effective date. 9

10 Be It Enacted by the Legislature of the State of Wyoming:

- 12 **Section 1.** W.S. 9-4-719(b)(intro), (q)(intro), (i)
- 13 and (ii) is amended to read:

- spending 15 9-4-719. Investment earnings policy
- 16 permanent funds.

2	(b) There is created the permanent Wyoming mineral
3	trust fund reserve account. All funds within the account
4	shall be invested by the state treasurer as authorized
5	under W.S. $9-4-715(a)$, (d) , (e) and (r) and all investment
6	earnings from the account shall be credited to the account.
7	Beginning July 1, 2016 for fiscal year 2017 and each fiscal
8	year thereafter, the state treasurer shall transfer
9	unobligated funds from this account to the general fund as
LO	necessary to ensure that an amount equal to two and
L1	one-half percent (2.5%) of the previous five (5) year
L2	average market value of the permanent Wyoming mineral trust
L3	fund, calculated on the first day of the fiscal year, is
L 4	available for expenditure annually during each fiscal year.
L5	As soon as possible after the end of each of the fiscal
L6	years beginning on and after July 1, 2017, after making any
L 7	transfer required pursuant to paragraph (i) of this
L8	subsection, revenues in this account in excess of one
L9	hundred fifty percent (150%) of the spending policy amount
20	in subsection (d) of this section shall be credited to the
21	permanent Wyoming mineral trust fund. For fiscal year 2020
22	and for each fiscal year thereafter:

1 (q) The earnings from the permanent Wyoming mineral
2 trust fund under W.S. 9-4-204(u)(iii) during each fiscal
3 year beginning July 1, 2016—2022 for fiscal year 2023,
4 which are less than the spending policy established in
5 subsection (d) of this section are appropriated from the
6 general fund subject to subsection (s) of this section and
7 the following:

9 (i) Except as provided in paragraph (iii) of 10 this subsection, Any earnings in excess of two and one-half percent (2.5%) of the previous five (5) year average market 11 12 value of the trust fund, calculated from the first day of 13 the fiscal year and less than or equal to the spending policy amount specified in subsection (d) of this section 14 shall be credited to the legislative stabilization reserve 15 16 account created by W.S. 9-4-219; and the strategic 17 investments and projects account created by W.S. 9-4-220 in 18 equal amounts;

(ii) The appropriations appropriation in this subsection shall be credited to the designated account as soon as practicable after the end of the fiscal year but no

1 later than ninety (90) days after the end of the fiscal

4 **Section 2.** W.S. 9-4-219(c), 9-4-220, 9-4-220.1,

9-4-715(p)(vi) and 9-4-719(b)(i) and (q)(iii) are repealed.

7 Section 3. On July 1, 2022, all funds in the 8 legislative deficit control account within the legislative stabilization reserve account, the strategic investments 9 10 and projects account and the school major maintenance 11 subaccount within the strategic investments and projects 12 account shall be transferred to the general fund. On July 13 1, 2022, all funds in the Wyoming state penitentiary capital construction account within the 14 strategic 15 investments and projects account shall be transferred to 16 legislative stabilization reserve account. Any 17 unexpended funds that have been appropriated from the accounts and subaccounts specified in this section, except 18 19 for the Wyoming state penitentiary capital construction 20 account within the strategic investments and projects account, prior to July 1, 2022 shall be paid from the 21 Any unexpended funds that have been general fund. 22 appropriated from the Wyoming state penitentiary capital 23

- 1 construction account within the strategic investments and
- 2 projects account prior to July 1, 2022 shall be paid from
- 3 the legislative stabilization reserve account. Except as
- 4 otherwise provided in this section, any funds that are
- 5 directed by law to revert to the accounts and subaccounts
- 6 specified in this section shall revert to the general fund.
- 7 Any funds that are directed by law to revert to the Wyoming
- 8 state penitentiary capital construction account within the
- 9 strategic investments and projects account shall revert to
- 10 the legislative stabilization reserve account.
