The 3 implementation report shall: 4 5 (i) Identify medical conditions that are, according to medical evidence, 6 likely to benefit from 7 treatment with medical marijuana; 8 9 (ii) Include recommendations on how to regulate 10 medical marijuana prescriptions including any 11 recommendations related to prescriber and dispenser 12 regulation and responsibility; 13 14 (iii) Include recommendations on how to prevent wrongfully obtained prescriptions and misuse of medical 15 16 marijuana and how to promote the legitimate medical use of 17 marijuana; 18 19 (iv) Recommend a timeline for implementation and 20 regulation of medical marijuana in Wyoming; 21 Identify and recommend statutory 22 (v) changes 23 that are necessary to implement the use of medical

4 (b) The state health officer shall provide the report 5 required under this section to the joint labor, health and 6 social services interim committee not later than September 7 30, 2021.

8

9 Section 2. There is appropriated thirty thousand dollars (\$30,000.00) from the general 10 fund to the 11 department of health. This appropriation shall be for the period beginning with the effective date of this act and 12 13 ending June 30, 2022. This appropriation shall only be expended for costs necessary to prepare the report as 14 required by section 1 of this act. Notwithstanding any 15 16 other provision of law, this appropriation shall not be 17 transferred or expended for any other purpose and any unexpended, unobligated funds 18 remaining from this 19 appropriation shall revert as provided by law on June 30, 20 2022.
