6 Be It Enacted by the Legislature of the State of Wyoming:

8 Section 1.

9

10 (a) As used in this act:

11

12 (i) "American Rescue Plan Act funds" means funds

13 appropriated or disbursed to the state of Wyoming through

14 the Coronavirus State Fiscal Recovery Fund established

15 under section 602 of title VI of the federal Social

1 Security Act, as created by section 9901 of the American

2 Rescue Plan Act of 2021, P.L. No. 117-2;

4 (ii) "Entity" means a person or entity eligible

5 for funding pursuant to the American Rescue Plan Act of

6 2021, subject to any further eligibility requirements or

7 prioritization developed by the Wyoming water development

8 office;

9

10 (iii) "Eligible project" means those categories

11 and types of projects authorized to receive funding

12 pursuant to the American Rescue Plan Act of 2021, P.L. No.

13 117-2.

14

15 (b) The Wyoming statewide American Rescue Plan Act

16 water infrastructure program is hereby created. The Wyoming

17 water development office shall establish and administer

18 this temporary program for the purpose of providing grants

19 to entities for eligible projects. The office of state

20 lands and investments and department of environmental

21 quality shall consult with and provide technical assistance

1 to the Wyoming water development office in the

2 establishment and administration of this temporary program.

3 The directors of the Wyoming water development office,

4 office of state lands and investments and department of

5 environmental quality may establish an informal working

6 group to facilitate any consultation and technical

7 assistance between the three agencies. Grants shall be

8 awarded under this act in accordance with the following:

9

The Wyoming water development office, 10 (i) 11 consultation with the office of state lands and investments 12 and the department of environmental quality, shall develop an application process, including required documentation 13 and application deadlines, for entities to apply to receive 14 a grant under this act for eligible projects. Any entity 15 16 may apply for grant funding pursuant to the application 17 process established by the office. Upon receipt of 18 application, the Wyoming water development office, consultation with the office of state lands and investments 19 20 and the department of environmental quality, shall review applications to determine whether the project for which an 21

1 entity has submitted an application is an eligible project.

2 The water development office may require an applicant

3 entity to submit any additional information necessary to

4 determine project eligibility;

5

6 (ii) The Wyoming water development office shall

7 evaluate and prioritize eligible projects for

8 recommendation to the Wyoming water development commission,

9 including a recommended grant award amount. The Wyoming

10 water development office, in consultation with the office

11 of state lands and investments and department of

12 environmental quality, shall develop criteria to evaluate

13 and prioritize projects and grant funding, provided that

14 grants awarded for each eligible project shall not exceed

15 eighty-five percent (85%) of the estimated project costs or

16 seven million five-hundred thousand dollars

17 (\$7,500,000.00), whichever is less;

18

19 (iii) Upon determination by the Wyoming water

20 development office that an entity has submitted a grant

21 application for an eligible project, the water development

office shall forward the determination of eligibility and 1 2 potential prioritization, including funding recommendation, to the Wyoming water development commission. The Wyoming 3 water development commission shall make the final decision 4 regarding approval and prioritization of the eligible 5 6 project for inclusion in the program and grant award 7 amounts; 8 9 (iv) The Wyoming water development commission and Wyoming water development office shall report the 10 approved projects and awarded grant amounts to the select 11 12 water committee; 13 14 (v) Decisions of the Wyoming water development commission, Wyoming water development office, office of 15 16 state lands and investments and department of environmental 17 quality relating to determinations of project eligibility

and prioritization, including recommendations relating to

grant award amounts, are specifically exempt from all

provisions of the Wyoming Administrative Procedure Act

4	(vi) Subject to federal law, a grant awarded
5	under this act shall be conditioned upon an entity agreeing
6	to be responsible for:
7	
8	(A) Compliance with all requirements of the
9	American Rescue Plan Act of 2021, P.L. No. 117-2;
10	
11	(B) The operation and maintenance of the
12	project;
13	
14	(C) All project expenditures in excess of
15	the total project grant award amount;
16	
17	(D) Repaying the entirety, or a portion, of
18	the grant award if the entity abandons completion of the
19	project, or if a portion of the project is ultimately
20	determined to be ineligible for American Rescue Plan Act
21	funds;

2	(E) Any additional consideration deemed
3	necessary by the Wyoming water development office to
4	protect the use of public funds;
5	
6	(F) Expending grant funds prior to December
7	1, 2026.
8	
9	(c) The Wyoming water development office shall report
10	to the joint appropriations committee a summary of grants
11	awarded under this act.
12	
13	(d) Grants under this act shall be awarded prior to
14	October 1, 2024. The program shall terminate on December
15	30, 2026.
16	
17	Section 2. The Wyoming water development office shall
18	promulgate rules necessary to administer the program
19	authorized by this act. The office of state lands and
20	investments and the department of environmental quality may

1 promulgate rules necessary to assist with the program

2 authorized by this act.

3

4 Section 3. There is appropriated to the Wyoming water development office ninety-five million 5 dollars 6 (\$95,000,000.00) from any unexpended, unobligated American 7 Rescue Plan Act funds that were appropriated in 2021 Wyoming Session Laws, Chapter 166, Section 5(b). This 8 9 appropriation is for purposes of this act and that are consistent with the terms of the American Rescue Plan Act, 10 11 excluding the provision of government services related to a 12 reduction in revenue. Any unexpended, unobligated funds remaining from this appropriation on October 1, 2024, may 13 be transferred and expended upon approval by the governor 14 for any other purposes authorized by the legislature and 15 16 consistent with the terms of the American Rescue Plan Act. 17 Transfers and expenditures under this section shall be 18 reported to the legislature through the B-11 process as 19 authorized by W.S. 9-2-1005(b)(ii) and reported pursuant to 20 W.S. 9-2-1013(b).
