5 Be It Enacted by the Legislature of the State of Wyoming:

7 **Section 1**. W.S. 21-9-102 is amended to read:

- 9 21-9-102. Instruction in state and federal
- 10 constitutions required; limitation; satisfactory
- 11 examination a prerequisite to graduation.

- 13 (a) All schools and colleges in this state that are
- 14 supported in any manner by public funds shall give
- 15 instruction in the essentials of the United States

1	constitution and the constitution of the state of Wyoming,
2	including the study of and devotion to American institution
3	and ideals, and no student shall receive a high school
4	diploma, associate degree or baccalaureate degree without
5	satisfactorily passing an examination on the principles of
6	the constitution of the United States and the state of
7	Wyoming. The instruction shall be given for at least three
8	(3) years in kindergarten through grade eight (8) and for
9	one (1) year each in the secondary and college grades.
10	
11	(b) Instruction on the topics enumerated in this
12	section and any supporting materials shall be consistent
13	with the following principles of individual freedom:
14	
15	(i) No person is inherently racist, sexist or
16	oppressive, whether consciously or unconsciously, solely by
17	virtue of his race or sex;
18	
19	(ii) No race is inherently superior to another
20	race;
21	
22	(iii) No person shall be discriminated against
23	or receive adverse treatment solely or partly on the basis

1	of race, color, national origin, religion, disability or
2	sex;
3	
4	(iv) Meritocracy or traits, including a hard
5	work ethic, are not racist but are fundamental to the right
6	to pursue happiness and to be rewarded for industriousness;
7	
8	(v) No person, by virtue of his race or sex,
9	bears responsibility for actions committed in the past by
10	other members of the same race or sex;
11	
12	(vi) No person shall be made to feel discomfort,
13	guilt, anguish or any other form of psychological distress
14	on account of his race;
15	
16	(vii) Instructional personnel may facilitate
17	discussions and use curricula to address, in an
18	age-appropriate manner, the topics of sexism, slavery,
19	racial oppression, racial segregation and racial
20	discrimination, including topics relating to the enactment
21	and enforcement of laws resulting in sexism, racial
22	oppression, racial segregation and racial discrimination.
23	Classroom instruction and curricula shall not be used to

1	indoctrinate or persuade students to a particular point of
2	view inconsistent with the principles of this subsection or
3	state academic standards.

5	Section 2. This act is effective July 1, 2022.
