1 AN ACT relating to elections; amending procedures for

2 filling vacancies in specified federal and state offices;

3 requiring special elections as specified; making conforming

4 amendments; repealing obsolete provisions; and providing

5 for an effective date.

7 Be It Enacted by the Legislature of the State of Wyoming:

9 **Section 1.** W.S. 9-1-212, 9-1-802(e),

10 22-2-101(a)(iii), 22-2-110(a), 22-2-111(a), 22-18-103,

11 22-18-105 through 22-18-109, 22-18-111(a)(intro) and

12 (iii)(intro) and 28-1-106 are amended to read:

9-1-212. Vacancy in office of governor; term of

2 successor; when election held to fill unexpired term;

3 requirements of elections; term of person elected.

4

Whenever the powers and duties of the office of the 5 governor of the state of Wyoming devolve upon any other 6 person as provided in W.S. 9-1-211(a), the person acting as 7 8 governor shall continue to act as governor until the end of the term of the governor if the office is assumed less than 9 10 sixty (60) days before the next general election. If the 11 office is assumed more than sixty (60) days before a 12 general election the person acting as governor shall issue an additional proclamation calling for the election of a 13 governor to fill the unexpired term, which election shall 14 15 take place at the same time as the general election, and 16 the election, together with the returns and canvass 17 thereof, shall be conducted in all respects as though it was an original election for governor. When the state 18 19 canvassing board canvasses the vote of the election and 20 declares a person at the election to be elected as governor, the person call for a special election as 21 provided in W.S. 22-18-103 through 22-18-109. The candidate 22 issued a certificate of election pursuant to W.S. 22-18-109 23

10 (a) Except for special elections to fill vacancies for a congressman under W.S. 22-18-105 22-18-103 through 11 12 22-18-109, periods of time are computed by excluding the 13 specific day and counting the prescribed number of days, including Saturdays, Sundays and full legal holidays. If 14 15 the first day of a time period falls on a Saturday, Sunday 16 or full legal holiday, the preceding day which is not a 17 Saturday, Sunday or full legal holiday shall be used. If the last day of a time period falls on a Saturday, Sunday 18 19 or full legal holiday, the next day which is not a 20 Saturday, Sunday or full legal holiday shall be used. All 21 days, except the specific day, but including the last day, shall be used to compute the time limits established under 22 W.S.  $\frac{22-18-105}{2}$   $\frac{22-18-103}{2}$  through  $\frac{22-18-109}{2}$  unless the last 23

11 day of such election, entitled to absent himself from any

12 service or employment in which he is then engaged or

13 employed for a period of one (1) hour, other than meal

14 hours, the hour being at the convenience of the employer,

15 between the time of opening and closing of the polls. Such

16 elector shall not, because of so absenting himself, lose

17 any pay, providing he actually casts his legal vote.

For purposes of W.S. 22-18-103 through 22-18-109, "vacated office" means an 6 office specified in this section. 7 8 9 22-18-105. - 10 period specified in W.S. 22-18-106, the secretary of state
- 11 shall certify to the clerks of counties voting to fill the
- 12 vacancy the name of each candidate qualified to appear on
- 13 the ballot, and his the candidate's party affiliation or
- 14 independent status, if declared.

- 19 A candidate for the unexpired term of the a vacated office
- 20 of representative in congress may seek election only as a
- 21 candidate of the political party in which he the candidate
- 22 was registered on the date the vacancy occurred. A
- 23 candidate for the unexpired term of a vacated office of

- 1 representative in congress who was not registered with a
- 2 party on the date the vacancy occurred may run only as an
- 3 independent.

- 8 A special election to fill a vacancy shall be conducted by
- 9 the county clerk as nearly as possible in the manner of a
- 10 general election. The county clerk shall have twelve (12)
- 11 days to prepare the special election ballot after the
- 12 secretary of state's certification under W.S. 22-18-107.
- 13 The candidate who receives a plurality of the votes at a
- 14 special election shall be issued a certificate of election
- 15 as provided by law.

- 17 **22-18-111.** Vacancies in other offices; temporary

- 20 (a) Any vacancy in any other elective office in the
- 21 state except representative in congress or the offices
- 22 specified in W.S. 22-18-103 or the board of trustees of a
- 23 school or community college district, shall be filled by

1	the governing body, or as otherwise provided in this
2	section, by appointment of a temporary successor. The
3	person appointed shall serve until a successor for the
4	remainder of the unexpired term is elected at the next
5	general election and takes office on the first Monday of
6	the following January. Provided Except as provided in W.S.
7	22-18-105, if a vacancy in a four (4) year term of office
8	occurs in the term's second or subsequent years after the
9	first day for filing an application for nomination pursuant
10	to W.S. 22-5-209, no election to fill the vacancy shall be
11	held and the temporary successor appointed shall serve the

If the resigning member did not 17 represent a political party at the time of his election, or at the time of his appointment if not elected to office, 18 19 the governor shall notify the appropriate boards of county 20 commissioners who shall proceed in accordance with W.S. 22-18-111(a)(iii)(C). 21

1 (b) For purposes of this section a person shall be

2 considered to "represent" a political party if he the

3 person was a nominee of that political party when elected

4 to office or when appointed to fill a vacancy in office.

6 **Section 2.** W.S. 22-18-104 and 22-18-111(a)(i) are

7 repealed.

8

9 **Section 3.** This act is effective immediately upon

10 completion of all acts necessary for a bill to become law

11 as provided by Article 4, Section 8 of the Wyoming

12 Constitution.
