1	AN ACT relating to abortions; prohibiting abortions based
2	on selective reasons and disabilities; providing
3	definitions; providing a criminal penalty and disciplinary
4	sanctions for violations; imposing civil liability; making
5	conforming amendments; requiring rulemaking; and providing
6	for effective dates.

8	Be It Enacted by the Legislature of the State of Wyoming:

10	Section 1. W.S. 35-6-120 is created to read:

12	35-6-120. Abortions based on disability or other
13	selective reasons prohibited; penalties.

1 (a) No person shall intentionally perform, attempt to 2 perform or cause to be performed an abortion if the person 3 knows that the abortion is being sought solely: 4 5 (i) Because the unborn child, human fetus or human embryo has been diagnosed with a disability or has a 6 7 potential diagnosis of a disability; or 8 9 (ii) Because of the unborn child's, human 10 fetus's or human embryo's: 11 12 (A) Sex; 13 14 (B) Race; 15 16 (C) Color; 17 18 (D) National origin; or 19 20 (E) Ancestry. 21 (b) A person who violates subsection (a) of this 22 section is: 23

1 2 (i) Guilty of a felony punishable by 3 imprisonment for not more than fourteen (14) years; 4 (ii) Subject to civil liability for wrongful 5 6 death. 7 8 (c) Any health care provider licensed under title 33 of the Wyoming statutes who performs an abortion in 9 violation of this section shall be subject to discipline 10 under W.S. 33-1-118(c) and the applicable provisions of 11 12 title 33 of the Wyoming statutes. 13 14 Section 2. W.S. 33-1-118 by creating a new subsection (c) and 35-6-101(a) by creating new paragraphs (xii) and 15 16 (xiii) and by amending and renumbering (xii) as (xiv) are 17 amended to read: 18 19 33-1-118. Health care licensing boards; authority to 20 discipline licensees for sexual misconduct and performing prohibited abortions. 21 22

2	refuse to issue or renew, or may suspend or revoke the
3	license, certificate or temporary permit of any licensee or
4	certificate holder, or may otherwise discipline a licensee
5	or certificate holder, upon clear and convincing evidence
6	that the licensee or certificate holder has performed an
7	abortion prohibited under W.S. 35-6-120.

11	(a) As used in the act, unless the context otherwise

14	(xii) "Disability" means any disease, defect or
15	disorder that could substantially limit one (1) or more
16	major life activities including but not limited to a
17	physical, mental or intellectual disability, disorder or
18	disease, physical disfigurement, scoliosis, dwarfism, down
19	syndrome, albinism, amelia, meromelia or a lethal fetal
20	anomaly;

22	<u>(xiii) "Lethal fetal anomaly" means a fetal</u>
23	condition diagnosed before birth that, if the pregnancy

2	result in the death of the child not more than three (3)

10	(a) Before July 1, 2022, each licensing board with
11	the authority to license, supervise and discipline health
12	care providers shall review existing rules and promulgate
13	any new rules or amend existing rules to ensure compliance
14	with the provisions of this act.
15	
16	(b) As used in this section, "health care provider"
17	means a person who is licensed, certified or otherwise
18	authorized or permitted by the laws of this state to
19	provide care, treatment, services or procedures to
20	maintain, diagnose or otherwise treat a patient's physical
21	or mental condition.
