Catch Title: **State funded capital construction.**
Subject: State funded capital construction.

Summary/Major Elements:

- This act directs the deposit of rental income for portions of any building used as the quarters for the state trails program field office into the Snowmobile Trails Account and the Off-Road Recreational Vehicles Trails Account, in equal amounts.
- This act continuously appropriates funds from the Capitol Square Preservation Account for the maintenance, preservation, and enhancement of the capitol building and grounds, the capitol building extension, and the Herschler building.
- This act provides funding for state construction projects administered by the State Construction Department, including community college projects and other state agency projects, in the following amounts:
 - \$7,300,000 in General Funds;
 - \$62,428,183 in Federal Funds; and
 - \$121,074,773 in Other Funds.
- This act appropriates \$58,632,000 from the Strategic Investments and Projects Account (SIPA) to the University of Wyoming for design and construction of projects. Of this appropriation, \$50,000,000 SIPA is for three projects, Corbett natatorium, the west stands at War Memorial Stadium, and the college of law, in amounts to be allocated by the University Board of Trustees. The expenditure of this appropriation on these three projects is conditioned upon receiving matching funds in a ratio of \$1.00 SIPA to \$1.00 other funds. Any funds for the college of law are effective immediately.
- This act transfers any unappropriated funds in the Capitol Renovation and Restoration Account to the Capitol Square Preservation Account, effective immediately.
- This act appropriates \$250,000 General Funds to the Capitol Square Preservation Account for planning, development, and construction of a display for the Wyoming state constitution, effective immediately.
- This act authorizes the Department of State Parks and Cultural Resources (Department) to purchase land and appurtenant buildings to provide quarters to the state trails program field office for the support of the state trails program. The act appropriates \$1,400,000 from the Snowmobile Trails Account and
