14 The district adjusted average (II) 15 staffing category salary for each computed under 16 subdivision (I) of this subparagraph shall be further 17 adjusted for regional cost differences as measured by the greater of the hedonic wage index or the Wyoming cost-of-18 19 living index computed by the division of economic analysis, 20 department of administration and information, 21 minimum of one hundred (100) index value, as prescribed by the education resource block grant model. For purposes of 22 the education resource block grant model, the version of 23
