A BILL

for

1 AN ACT relating to the Wyoming Wildlife and Natural Resource Funding Act; providing for funding of 2 large projects under the act; specifying large projects approved 3 for funding in 2023; specifying conditions for 4 large project funding; authorizing distributions from the Wyoming 5 wildlife and natural resource trust income account for 6 7 approved large projects; providing for the reversion of 8 funds; and providing for an effective date. 9
