Witnessing of wills-remote methods.

A BILL

for

1 AN ACT relating to wills; authorizing witnesses to wills to 2 appear electronically as specified; making conforming 3 amendments; and providing for an effective date. 4 5 Be It Enacted by the Legislature of the State of Wyoming: б 7 Section 1. W.S. 2-6-112 and 2-6-114(a) and (c) are 8 amended to read: 9 10 2-6-112. Will to be in writing; number and competency 11 of witnesses; signature of testator; subscribing witness 12 not to benefit; exception. 13 14 (a) Except as provided in the next section W.S. 15 2-6-113, all wills to be valid shall be in writing, or

typewritten, witnessed by two (2) competent witnesses and 1 2 signed by the testator or by some person in his presence 3 and by his express direction. If the witnesses are 4 competent at the time of attesting the execution of the 5 will, their subsequent incompetency shall not prevent the probate and allowance of the will. No subscribing witness б to any will can derive any benefit therefrom unless there 7 8 are two (2) disinterested and competent witnesses to the same, but if without a will the witness would be entitled 9 10 to any portion of the testator's estate, the witness may 11 still receive the portion to the extent and value of the 12 amount devised.

(b) Witnesses to a will may appear in person or by 14 15 the use of audio-video communication technology due to 16 public health restrictions or other exigent circumstances, 17 provided that the witnesses can see and hear the testator 18 in real time, have the opportunity to judge the competency 19 of the testator, have the ability to securely sign the will 20 electronically and can determine that the testator is 21 freely and voluntarily signing and executing the will. 22
