1 AN ACT relating to public health and safety; prohibiting physicians from performing procedures for children related 2 3 to gender transitioning and gender reassignment; providing an exception; providing that gender transitioning 4 reassignment procedures are grounds for suspension or 5 revocation of a physician's license; prohibiting insurance 6 7 coverage for children for gender transitioning reassignment procedures; providing definitions; specifying 8 9 applicability; requiring rulemaking; and providing for 10 effective dates.

1 (a) As used in this section:

3 (i) "Child" means a person who is younger than

4 eighteen (18) years of age;

5

6 (ii) "Health care provider" means a person other

7 than a physician who is licensed, certified or otherwise

8 authorized by Wyoming law to provide or render health care

9 or to dispense or prescribe a prescription drug in the

10 ordinary course of business or practice of a profession;

11

12 (iii) "Physician" means any person licensed to

13 practice medicine in this state by the state board of

14 medicine under the Medical Practice Act.

15

16 (b) For purposes of transitioning a child's

17 biological sex as determined by the sex organs and except

18 as provided by subsection (c) of this section, chromosomes

19 and endogenous profiles of the child or affirming the

20 child's perception of the child's sex if that perception is

21 inconsistent with the child's biological sex, no physician

22 or health care provider shall:

1 (i) Perform a surgery that sterilizes the child, 2 including castration, vasectomy, hysterectomy, 3 oophorectomy, metoidioplasty, orchiectomy, penectomy, 4 phalloplasty and vaginoplasty; 5 6 (ii) Perform a mastectomy; 7 8 (iii) Provide, administer, prescribe or dispense any of the following prescription drugs that induce 9 transient or permanent infertility: 10 11 12 (A) Puberty suppression or blocking prescription drugs to stop or delay normal puberty; 13 14 15 (B) Supraphysiologic doses of testosterone 16 to females; 17 (C) Supraphysiologic doses of estrogen to 18 19 males. 20 21 (iv) Remove any otherwise healthy or non-diseased body part or tissue. 22

1 (c) Subsection (b) of this section shall not apply to

2 procedures or treatments that are performed with the

3 consent of the child's parent or guardian and are for a

4 child who is born with a medically verifiable genetic

5 disorder of sex development, including 46, XX chromosomes

6 with virilization, 46, XY with undervirilization or both

7 ovarian and testicular tissue.

10 creating a new paragraph (xi) and 33-26-402(a) by creating

11 a new paragraph (xxxvi) are amended to read:

33-24-122. Revocation or suspension of license and

17 (a) The license and registration of any pharmacist

18 may be revoked or suspended by the board of pharmacy or the

19 board may issue a letter of admonition, refuse to issue or

20 renew any license or require successful completion of a

21 rehabilitation program or issue a summary suspension for

- 2 delivered or issued for delivery in this state on and after
- 3 July 1, 2023.

- 5 (b) W.S. 35-4-1001, as created by section 1 of this
- 6 act, shall apply only to conduct or procedures occurring on
- 7 and after the effective date of this act.

- 9 **Section 4.** The insurance commissioner, department of
- 10 health, state board of medicine and state board of pharmacy
- 11 shall promulgate all rules necessary to implement this act.

- 15 (a) Except as provided in subsection (b) of this
- 16 section, this act is effective July 1, 2023.
