(b) There is appropriated six hundred thousand dollars (\$600,000.00) from the public service commission account under W.S. 37-2-106 within the special revenue fund to the public service commission for purpose of funding the positions authorized in subsection (a) of this section. This appropriation shall be for the period beginning with the effective date of this act and ending June 30, 2026. This appropriation shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2026."
