"(d) Not later than October 1, 2023, and each October 1 thereafter through October 1, 2028, the state superintendent, in consultation with the state construction department, shall provide to the joint education interim committee and the joint appropriations committee a report identifying the fiscal impact on the school foundation program account, the education resource block grant model as defined by W.S. 21-13-101(a)(xiv) and the school capital construction account as a result of the operation of the three (3) charter schools approved by the state loan and investment board and the ~~one (1)~~ three (3) charter ~~school~~ schools which may be approved by the Wyoming charter school authorizing board. The reports shall specify the fiscal impact

at the district and the school level and shall at minimum identify the amounts generated under W.S. 21-3-314(c), as amended by this act, and amounts for facility needs, including but not limited to lease amounts, expenditure or requests for major building and facility repair and replacement under W.S. 21-15-109 and any other requests related to capital construction projects.".
