The department of education shall maintain the total amount of direct expenditures for and grants to local school districts in support of applied agriculture and farming programs during the 2025-2026 fiscal biennium as compared to the 2023-2024 fiscal biennium. 3. Of this general fund appropriation, thirty-three thousand four hundred seventy-six dollars (\$33,476.00) is appropriated for increased compensation and employer paid benefits for two (2) positions within the finance unit.

5. Of this general fund appropriation, fifty thousand dollars (\$50,000.00) is appropriated to pay for processing costs for Wyoming poultry, lamb, pork, beef or bison donated to a school district to be used in school meals. Expenditures authorized in this footnote shall be made only if an equal amount of funding has been contributed by a local school district for the processing costs of the donated Wyoming poultry, lamb, pork, beef or bison. The department shall endeavor to provide funding to as many school districts as possible under this footnote and participation in the federal school lunch program shall not be used as a limiting criterion for the distribution of these funds. To the extent all funds from this appropriation are expended, the department of education shall identify other funds appropriated in this section for continuation of the expenditures under this footnote.

6. Of this general fund appropriation, four hundred ninety-six thousand eight dollars (\$496,008.00) is appropriated, and of these authorized employees, two (2) full-time positions are authorized for outreach for the deaf and hard of hearing unit.

7. Of this general fund appropriation, three hundred ten thousand five dollars (\$310,005.00) is appropriated, and of the authorized employees two (2) full-time employee positions are authorized, for purposes of instructing students who are deaf or hard of hearing. This appropriation shall not be transferred or expended for any other purpose. It is the intent of the legislature that of this appropriation, two hundred forty-eight thousand four dollars (\$248,004.00) be doubled and included in the department of education's standard budget for the immediately succeeding fiscal biennium."

(a) There is appropriated seventy-two million dollars (\$72,000,000.00) from the general fund to the department of revenue to be expended only for payments to qualifying counties under this section. This appropriation shall not be transferred or expended for any other purpose. Notwithstanding W.S. 9-2-1008, 9-2-1012(e) and 9-4-207, any unexpended, unobligated funds remaining from this appropriation shall not revert until June 30, 2027. It is the intent of the legislature that this appropriation not be included in the standard budget of the department of revenue for the immediately succeeding fiscal biennium.

(b) The department of revenue shall establish a grant application and program for distribution of the funds appropriated in subsection (a) of this section and as specified in this subsection. Not more than one-half (1/2) of the amount appropriated in subsection (a) of this section may be distributed for purposes of restoring revenue attributable to any reduction in residential property tax assessments from tax year 2025. Any remaining funds from the appropriation in subsection (a) of this section shall be available for distribution for purposes of restoring revenue attributable to any reduction in residential property tax assessments from tax year 2026.

(c) The following shall apply to grants made under this section:

(i) No school district shall qualify for a grant under this section;

(ii) Subject to paragraph (iii) of this subsection, only counties, cities and towns that are, or are located within, the counties with the eight (8) lowest total assessed valuations for the current tax year, as certified by the department of revenue, shall qualify for grants under this section;

(iii) Only counties, cities and towns within the counties qualifying under paragraph (ii) of this subsection that also each impose the maximum statutory mill levy authorized to be imposed by the applicable governing board shall qualify for grants under this section;

(iv) Any special district that also imposes the maximum statutory mill levy authorized to be imposed by the applicable governing board shall qualify for grants under this section.

(d) Counties qualified under subsection (c) of this section and any special district located outside of a county qualified under subsection (c) of this section shall prepare a grant application to the department of revenue on behalf of the county and all cities, towns and qualifying special districts in the county. If awarded grant funds under this section, the county shall distribute the funds in proportion to the demonstrated reduction in residential

property tax assessments as compared to tax year 2024 and directly attributable to legislation exempting or otherwise reducing residential property tax assessments enacted during the 2025 general session.

(e) Grants awarded under this section shall not exceed an amount equal to seventy-five percent (75%) of the demonstrated reduction of residential property tax assessments as compared to tax year 2024 and directly attributable to legislation exempting or otherwise reducing residential property tax assessments enacted during the 2025 general session. If funds appropriated under subsection (a) of this section and allocated for tax years 2025 and 2026 are insufficient to restore the demonstrated reduced residential property tax assessments under this section, the department of revenue shall make the grant awards on a pro rata basis.

(f) The department of revenue shall administer the program under this section and shall promulgate all rules necessary to implement this section.

(g) This section shall only be effective if:
