Page 1-line 14 After "." insert "Not later than school year 2026-2027, all door securement devices utilized in any public school building shall be from the list of approved door securement devices published by the state fire marshal pursuant to W.S. 35-9-107(d).".

Page 3-lines 6 through 12 Delete entirely and insert:

"(d) Not later than July 1, 2025, the state fire marshal shall provide the board of trustees in each school district with a list of door securement devices appropriate to be utilized in K-12 public school buildings. The state fire marshal may update the list of approved devices annually."

Page 3-line 14 Delete "July 1, 2025." and insert "immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.". ANDREW, CHAIRMAN
