"Section 4.

(a) Notwithstanding W.S. 9-2-1008 and 9-4-207, of unexpended, unobligated monies in the state shooting complex account created by 2023 Wyoming session laws, chapter 146, section 3, ten million dollars (\$10,000,000.00) or as much thereof as is available, and an additional three million dollars (\$3,000,000.00) from the Wyoming tourism reserve and projects account are appropriated to the department of state parks and cultural resources for the development, siting and construction of roads, motorized trails, parking areas, recreation vehicle and camping sites, shooting bays, buildings and other facilities for the Wyoming state shooting complex. Notwithstanding W.S. 9-2-1008 and 9-4-207, any unexpended, unobligated funds from these appropriations shall not revert and are authorized to be expended for the operation and maintenance of the Wyoming state shooting complex. These appropriations shall not be transferred or expended for any other purpose.

(b) If 2025 Senate File 0001 or 2025 House Bill 0001 is enacted into law, the appropriations in subsection (a) of this section shall be reduced by one dollar (\$1.00) for every one dollar (\$1.00) appropriated to the department of state parks and cultural resources for the Wyoming state shooting complex in 2025 Senate File 0001 or 2025 House Bill 0001."
