**Treatment of animals.**

Sponsored By: Representative(s) Byron, Schmid, Singh and Williams and Senator(s) Barlow, Hutchings, Landen, Nethercott and Olsen

AN ACT relating to crimes and offenses; providing a misdemeanor offense and amending the offense of felony animal cruelty to address actions where wildlife is reduced to possession; prohibiting the torture of wildlife as specified; specifying the required treatment of certain wildlife; specifying penalties; providing for license revocation and suspension and forfeiture of devices and equipment for specified convictions; clarifying trapping requirements; removing a reporting requirement; providing definitions; making conforming amendments; and providing for an effective date.

**"6-3-1004. Penalties; misdemeanor offenses.**

(c) A first offense of cruelty to animals under W.S. 6-3-1005(a)(iii) and 23-3-103(d) is a misdemeanor punishable by imprisonment for not more than six (6) months, a fine of not more than five thousand dollars (\$5,000.00), or both. The person shall also be subject to revocation and suspension of licenses and privileges as provided in W.S. 6-3-1005(c) and W.S. 23-3-103(d)."

Page 2-line 21 After "(a)" insert "Except as provided in W.S. 6-3-1004(c) and paragraph (a)(iii) of this section".

Page 3-line 10 Delete "any".

Page 4-after line 2 Insert:

"(C) A first offense of cruelty to animals under this paragraph and W.S. 23-3-103(d) is a misdemeanor punishable as provided in W.S. 6-3-1004(c). A second or subsequent offense under this paragraph or W.S. 23-3-103(d) is punishable as provided by subsections (b) and (c) of this section."

Page 4-line 4 Delete "this section" insert "a first or subsequent violation of paragraph (a)(iii) of this section and W.S. 23-3-103(d)".

Page 4-line 6 Delete "available" and insert "issued".

Page 4-line 8 Delete "under" and insert "as specified in".

Page 4-line 10 Delete "23-6-206" and insert "23-6-206(a)(iii)".

Page 5-line 3 After "released" insert "subject to subsection (d) of this section".

Page 5-after line 3 Insert and renumber as necessary:

"(d) No person shall knowingly, and with intent to cause undue suffering, torture, torment or mutilate living wildlife, including predatory animals and predatory birds, after reducing the living wildlife to possession. A person violating this subsection shall be liable under W.S. 6-3-1004(c) for a first offense and under W.S. 6-3-1005(a)(iii), (b) and (c) for a second or subsequent offense. Upon any conviction of a violation of this subsection the court may revoke any license issued under this act and suspend a person's privilege to purchase or receive any other license under this act or to take any wildlife as provided under W.S. 23-6-206(a)(iii). For purposes of this subsection, "wildlife" means as defined by W.S. 6-3-1001(a)(vi)."

"(iii) Up to three (3) years for conviction of a low misdemeanor as provided in W.S. 23-6-202(a)(v) or for conviction of a violation of W.S. 6-3-1005(a)(iii) or W.S. 23-3-103(d);"

Page 5-after line 15 Insert:

"(a) The following shall apply to the taking of wildlife:

(i) When on a person's private land, no person shall harass, pursue, hunt, shoot, or kill any Wyoming wildlife except predatory animals with, from, or by use of any aircraft, automotive vehicle, trailer, motor-propelled wheeled vehicle, or vehicle designed for travel over snow;

(ii) When on public land, no person shall:

(A) Pursue, hunt, shoot or kill any Wyoming wildlife except predatory animals or predacious birds from or by use of any aircraft, automotive vehicle, trailer, motor-propelled wheeled vehicle or vehicle designed for travel over snow;

(B) Harass, injure or kill any Wyoming wildlife, predatory animals or predacious birds with an automotive vehicle, trailer, motor-propelled wheeled vehicle or vehicle designed for travel over snow.

(iii) No person shall use any aircraft, to aid in the taking of any Wyoming wildlife, except predatory animals, whether by spotting or locating the wildlife, communicating with any person attempting to take the wildlife, or by providing other aid to any person taking the wildlife. Nothing in this subsection shall apply to the use of any aircraft by governmental agencies, their employees, contractors or designees performing any lawful duties. The commission may exempt handicapped hunters from any provision of this subsection. For purposes of this section "aircraft" means any machine or device capable of atmospheric flight including but not limited to an airplane, helicopter, glider, dirigible or unmanned aerial vehicle."
