At the discretion of the appropriate licensing authority, variances to this time requirement may be granted on a seasonal basis. As used in this paragraph, "full-service restaurant" means a restaurant where waiters deliver food and drink offered from a printed food menu to patrons at tables or booths and a restaurant that has a dining room or rooms, kitchen and the number and kind of employees necessary for the preparing, cooking and serving of meals. For purposes of this paragraph, the service of only fry orders or sandwiches, hamburgers or salads shall not qualify as a full-service restaurant;". GIERAU
