8 Be It Enacted by the Legislature of the State of Wyoming:

10 **Section 1**. W.S. 26-32-101(a) and (b) is amended to

13 **26-32-101.** Supervision and audit of funds; approval

14 of investment; promulgation of rules and regulations;

2 The department shall supervise and audit the 3 funds derived by any person either residing in or doing 4 business within the state, from prepaid or prearranged 5 funeral contracts providing for the sale of caskets, burial vaults, monuments or memorials or any burial supplies and 6 equipment and funeral services, if the sale is made, either 7 8 outright or on the installment basis, prior to the demise 9 of the person purchasing them or for whom they are 10 purchased, with the merchandise or service, or both, to be delivered at a future date at time of need. All funds 11 12 received from these contracts or arrangements by any person either residing in or doing business within this state 13 shall be received, invested and withdrawn according to 14 15 requirements the department approves. Investment in a bank, 16 trust company or federal building and loan association in 17 Wyoming is an approved investment. The deposit of funds received from the sale of these contracts or arrangements 18 19 in irrevocable pre-need funeral trusts, the funds of which 20 are invested in compliance with W.S. 4-10-901 and 4-10-902, 21 is an approved investment. Earnings, including interest, income and dividends, from any investment of an irrevocable 22 pre-need funeral trust may inure to the benefit of the 23

1 seller of the prepaid or prearranged funeral contract, but 2 shall be withdrawn from the irrevocable trust only upon the 3 occurrence of an event that requires withdrawal of the 4 corpus of the trust. Neither the person purchasing a prepaid or prearranged funeral contract nor any person for 5 whom the contract is purchased shall be entitled to 6 7 terminate or cancel the contract or make demand for the 8 funds paid for the contract after the funds are deposited

into an irrevocable pre-need funeral trust.

11 (b) The commissioner shall promulgate rules 12 regulations for the purposes specified in subsection (a) of this section to include regulation of contract provisions 13 and funds thereunder. The rules shall require notice to 14 15 buyers of prepaid or prearranged funeral contracts of the 16 types of investments into which funds derived from the sale 17 of these contracts may be deposited and the risks 18 associated with those investments. The rules shall require 19 notice to buyers of the ability to cancel or terminate a 20 contract or make demand for any amounts paid for the 21 contract. Rules promulgated by the commissioner shall not require any additional surety bond amount for those monies 22 23 deposited in an irrevocable pre-need funeral trust and
