Delete the Senate standing committee amendment (HB0019SS001/A) entirely and further amend as follows:

Page 2-line 8

After "parcels." insert "For purposes of this subsection:

(i) The lands owned by the state of Wyoming to which a person is authorized to access refers to lands owned or under the jurisdiction of the board of land commissioners, the state or any agency of the state that can be accessed by public road, public right-of-way, public easement, public waters, by adjacent state, local or federal land if that land is open to public use or by adjacent private land if the person has permission to cross that land from the landowner;

(ii) To be authorized to access lands owned by the state of Wyoming under this subsection, a person's use of the lands shall comply with the rules of the applicable agency that has jurisdiction over the lands."

Page 3-line 14

After "parcels." insert "For purposes of this paragraph:

(A) The lands owned by the state of Wyoming to which a person is authorized to access refers to lands owned or under the jurisdiction of the board of land commissioners, the state or any agency of the state that can be accessed by public road, public right-of-way, public easement, public waters, by adjacent state, local or federal land if that land is open to public use or by adjacent private land if the person has permission to cross that land from the landowner;
