AN ACT relating to state lands; removing the restriction on the number of authorized good neighbor authority employee positions; requiring employee positions to be funded only using funds from the Wyoming state forestry good neighbor authority revolving account; authorizing gifts, donations and bequests to be deposited into the account; prohibiting the acceptance of real property for purposes of the good neighbor authority; and providing for an effective date.
