Military Update

Air Guard Deployments

- Air Traffic Control Squadron Deployed 15 members to CENTCOM in April 2018
- Security Forces Squadron deployed 7 members to CENTCOM in July 2018
- Aeromedical Evacuation Squadron will deploy 23 members to CENTCOM, EUCOM & CONUS in January 2019
- Modular Airborne Fire Fighting System (MAFFS) supported firefighting in California and Colorado with numerous personnel July-September 2018

Army Guard Deployments

- G Company will deploy 30 Soldiers Jan 2019
- Det 6 will deploy 6 Soldiers May 2019
- 2-300 FA will deploy 120 Soldiers May 2019
- 115 FA BDE will deploy 92 Soldiers July 2019
- Target Accusation Platoon will deploy 23 Soldiers July 2019
- 2-300 FA will deploy 30 Soldiers September 2019

Background: Legislative Requirements



- Senate Enrolled Act 21 from the 2018 Budget Session
- Requires the Veterans' Commission, Dept. of Health, and Construction Dept. to pursue Level I / Level II study for Veterans' State Home Skilled Nursing Facility.
- These studies are defined in W.S. § 9-5-108
 - Level I "reconnaissance studies"
 - Level II "feasibility studies"
 - Level III "construction and operation plans"
- VA pays 65% construction if State commits 35% match.







Mission



- Two-part mission:
 - Provide subsidized long-term care benefit that veterans cannot access in Wyoming today.
 - Serve as a *safety-net* for veterans who cannot be served in private facilities.
 - ~15% safety-net (assaultive or selfinjurious behaviors)
- No more than 10% non-veterans







Capacity



- Modeled with 36 beds in 3 x 12-bed cottages.
 - Est. 300 veterans requiring SNF-level care.
 - At single location in State, travel-time likely means no more than *170* veterans.
 - Limited to 45 85 beds based on VA cap (if existing domiciliary beds reduced)
 - Start small










Notional Floorplan

Estimated Construction Costs



- At 2% interest over 15 years, the State Match can be seen (or paid off, if loaned) as an annual expense of:
 - ~\$543,000 for Buffalo
 - ~\$594,600 for Casper
 - ~\$587,900 for Sheridan









Location trade-offs (Casper)





Strengths:

- •Would serve the largest number of veterans due to its central location.
- •Large existing CNA workforce and access to CNA graduates.
- •Many local amenities for residents and visiting families.
- Above-average access to medical specialists.
- •Above-average number of veterans organizations.
- Donated land.

Weaknesses:

- Most expensive construction cost
- •No consolidation potential or continuity of care with existing facility.
- •Below average access to VA medical care.
- •CNA graduate pools have below-average pass rates.









Location trade-Offs (Buffalo)





Strengths:

- Lowest construction cost
- Above average number of Wyoming veterans served.
- Good opportunities for overhead consolidation and continuity of care with existing Veterans' Home.
- Good access to VA medical care.
- Relatively low labor costs.
- Most scenic location.
- State-owned land.

Weaknesses:

- Smaller existing pool of CNA labor means larger potential impact to local private SNFs.
- Below-average number of amenities and veterans organizations.
- Higher than average cost of living.











Location trade-offs (Sheridan)





Strengths:

- Best access to VA medical care.
- Opportunity to consolidate with existing Green House Living for Sheridan. Land will be donated, and facility has the only extensive Green House model experience in the State.
- Above-average access to existing CNA workforce and graduation sources.
- Above-average scenery and outdoor recreation.
- Donated land.

Weaknesses:

- Below-average number of veterans served due to location in the far north of the State.
- · Higher than average cost of living.









Operations



- With VA per-diem, will be self-sufficient. The key decision: how much are private-pay veterans charged?
 - Per the mission of the facility, should be lower than market (\$150/day compared to \$250/day).
 - However, the safety-net aspect of the facility requires higher operating cost than private facilities.
 - Cost-based Medicaid rate would allow benefit to average veteran, while preserving safety-net, but comes at annual cost of ~ \$250K SGF + \$250K FF.
 - "Formula-based" Medicaid rate (i.e., no net operating cost to SGF) would likely mean giving up safety net mission.
 - Note, however, that "safety net" veterans would still need to be served somewhere else (e.g. WSH/WLRC/WRC).





Request the JTIC to accomplish the following:

- Make recommendation on a final location
- Authorize and fund a Level III Study for the final location
- Separate bill to authorize the State to file for a VA State Home Grant and appropriate 35% SGF match.

Draft Bills









TAG Responsibilities W.S. §19-7-103

Legislature approved numerous revisions to T19 concerning the Guard Issue: the past few years to update the statutes. Interim Topic concern whether additional changes are needed and whether past changes require revisions to TAG responsibilities in W.S. §19-7-103.

Discussion:

- In 2017 Legislature passed SF 39 and SF 40 updating T19 on senior officer composition, clarifying TAG's title, and allowing electronic record keeping and related provisions
- W. S. §19-7-103 has three (3) subparagraphs that should be updated to reflect current electronic form/book use.

Recommendation: Committee at June 2018 meeting directed LSO draft bill to make revisions to 103. Draft bill before Committee as 19LSO-0014.

Update Title 19 National Guard Museum W.S. 19-14-112

<u>Issue</u>: The 1936 historic National Guard armory at 624 E. Pershing Blvd., Cheyenne, stores and displays Guard artifacts. Location not identified in statute as museum unlike Veterans Museum in Casper. This was 2018 Interim Topic.

Discussion:

- WOHS vacated building in 2008. Artifact storage and display greatly expanded with increased room
- Since 2010, Building maintained on federal facility list
- In 2014, all National Guard artifacts moved there now over 100,000 items
- With donations and grants, etc., contract employees/volunteers exhibit items and operate as museum open to public part-time

Recommendation: Committee at June 2018 meeting directed LSO draft bill to add property as a museum. Draft bill before Committee as 19LSO-0015.

Oregon Trail State Veterans Cemetery Funds W.S.19-14-108

<u>Issue:</u> W.S. 19-14-108, *Veterans' cemetery; acquisition and maintenance; eligibility for burial*, restricts all funds received from the VA and social security to be used ONLY for capital improvements.

Discussion:

- Current statute mandates that burial reimbursement funds from the Veterans Administration shall be applied for [cemetery] capital improvements only.
- The Wyoming Veterans Commission (WVC) would like the authority to also utilize the reimbursement funds for operations and maintenance at the cemetery saving the State money.
- Account currently has approximately \$100K that is not committed for future capital projects.

<u>Recommendation:</u> Amend W.S. 19-14-108 to allow funds collected to be "applied to the cemetery for capital improvements, operations and maintenance".... Draft bill is before the Committee as 19LSO-0016.

Military Code Jurisdiction W.S. 19-12-101

<u>Issue:</u> As part of the Interim Topic concerning updating existing military related statutes, an ambiguity was identified in the applicability of the Wyoming Military Code to Wyoming National Guard members outside of their time at duty. This was briefed at the June JTIC meeting.

Discussion:

- W. S. §19-12-101(d) concerning the Wyoming Military Code jurisdiction uses the term "duty status" without defining the phrase.
- This is a potential issue with, for example, illegal drug testing we perform monthly since the use most likely occurred before the member enters duty and provides a testing sample such as on a drill weekend.

Recommendation: Committee at June 2018 meeting directed LSO draft bill to amend existing statute to correct ambiguity. Draft bill is before the Committee as 19LSO-0017.
