How long will it take?

 Sourcing events for the first waves of spend categories is estimated to take 16 weeks. The savings from newly sourced categories are realized over the life of the awarded contracts and may continue in perpetuity as the Office of Procurement improves its supplier management and sourcing strategy.

How do we go get it?

Of course you do.

We recommend an A&M team to run sourcing events for the spend categories with the highest dollar savings and least complexity. Through this process, the A&M team would assist the Office of Procurement in transitioning into a more strategic approach to sourcing.




